PINE KNOLLS GOLF CLUB POLICIES & PROCEDURES EFFECTIVE APRIL 1, 2022

Pine Knolls Golf Club (PKGC) is not responsible for any damages, theft, etc. to any personal property on the club premises. Intentional damage to PKGC's course or property will result in automatic dismissal.

Calendar of events are made available at the clubhouse, on the website as well as through Facebook events. Additional changes may be made throughout the year so be sure to check periodically.

Residents with a Knoxville address can golf two times per year during golf season until Labor Day. After Labor Day, PKGC offers open golf. However, residents must become regular members to participate in PKGC events, with exception of open tournaments. Anyone living outside the area may become a member or may elect to pay green fees.

DUES

Membership dues, including cart space and/or trail fees, for the current year are outlined in Addendum A and are considered delinquent on June 1 unless you are on a scheduled payment plan. Members whose dues are delinquent are subject to a late fee and will forfeit all privileges until their account is made current.

To be eligible to vote as well as play in Sole Survivor, any person of legal age (18 years) may become a member of PKGC by purchasing a fully paid membership <u>and</u> a stock certificate for \$100.

Names of all members will be made available in the clubhouse on or before July 1 of each year.

No equipment or furnishings belonging to PKGC shall be loaned or removed from the premises for any occasion unless arrangements are made in advance. The member or members responsible for the same shall pay for any damage or destruction by member of equipment, furnishings, or property belonging to PKGC.

GOLF RULES & ATTIRE

All golfers, members, and non-members are requested to check in at the clubhouse. We would like to know how many people are using the course and in case of an emergency we would know if a person could be found on the golf course.

Soft spikes preferred. Unacceptable golf attire includes cut-off shirts, halter tops, swimsuits, and the like.

Proper golf etiquette on the course is always required! Fivesomes and gangsomes are only allowed subject to current traffic on course and prior approval is given by the inside staff member. Should pace of play become an issue, any fivesome or gangsome will be required to split up. Any group of players not keeping pace on the course must allow those following to pass through if the hole in front is open. No more than two carts per group. If you are part of a fivesome or gangsome, then prior approval is required.

You may take a mulligan on the first hole only; play no more than 1 ball on the remaining holes unless you are out of bounds or a lost ball. You then have three minutes to look for it. If not found, lay a ball down and play it. Play ready golf – be ready to hit when it is your turn.

Must be age 16 with a valid driver's license to rent a Pine Knolls rental cart or age 14 to drive a private cart without an adult. No child under the age of 13 shall be allowed to use the course on weekends or holidays unless with a parent, guardian, or other adult player.

Turf out or displaced by a player should be replaced at once and pressed down by your foot. Rake sand traps, replace divots, and fix ball marks!

Keep golf carts 15 yards away from greens. Drive carts in the rough between shots. Use the 90-degree rule when crossing fairways.

Non-resident guests may use the golf course upon registering at the clubhouse and payment of green fees and cart rental. Members may bring guests, but applicable fees will apply.

Non-resident golf carts may be used after paying the applicable trail fee. The Superintendent shall determine under what fairway condition carts may be used.

Please obey all signs and chained/roped areas. Keep carts away from clubhouse entrance.

In addition, the following rules apply during golf season with exception of Nationals where open golf is offered.

WEDNESDAYS

- Ladies' Day
 - o Before 11am
 - Female golfers and their female guests only.
 - o After 11am
 - Open golf

THURSDAYS

- Men's Day
 - Before 12pm (Open Golf):
 - Members (male or female; single, household, 25-mile, corporate, or student) and their guests as well as non-members/walk-on greens fees may play subject to fees when applicable.
 - 12pm to 4pm [Members & Guest(s); Excludes Walk-on Greens Fees]:
 - All Members and their guests may play subject to fees when applicable.
 - Student members must be in high school, entering high school in the fall of the current year or at least age 14.
 - Walkers under the age of 18 are prohibited.
 - After 4pm:
 - Male members age 18+ only and their male guests age 18+ (golfing or as passenger).

IT IS REQUIRED BY LAW THAT ALL ALCOHOLIC BEVERAGES BE PURCHASED THROUGH PKGC. PKGC ALSO RESERVES THE RIGHT TO INCLUDE BEER, WINE, SELTZERS, ETC TO THIS RULING. ALL LIKE BEVERAGES MUST BE PURCHASED IN THE CLUBHOUSE.

Soda and alcoholic beverages must be purchased through PKGC for any event. Bartenders can be made available through PKGC for an additional fee.

Golf and cross-country meets scheduled at PKGC will be noted on the calendar of events. The golf course will close at 3pm for each event.

Any consumption of personal alcohol (including those individuals you are employing) will result in forfeiture of Cleaning/Deposit Fee and alcohol will be confiscated. All soft drinks are to be purchased from Pine Knolls. No smoking inside the building.

A Pine Knolls employee is <u>required</u> for every party. There will be a charge of \$15.00 per hour for each employee working. The number of guests and type of bar service will determine the number of Pine Knolls employees needed. Bartenders will be Pine Knolls employees only. All guests must have picture identification as the bartenders are required to see proof of age.

Cleaning deposit will be refunded if the clean-up meets the approval of the manager's inspection (subject to "cleaning requirements"). Cleaning must be done immediately after rental if clubhouse is not open the next day, or by agreement with the manager that all clean-up will be completed before Noon the following day. You may also choose to have Pine Knolls employees clean but will forfeit your cleaning/damage deposit.

- RENTER IS REQUIRED TO KEEP ALL GUESTS OFF OF THE GOLF COURSE.
- RENTER IS RESPONSIBLE FOR DAMAGE THAT IS DONE TO THE COURSE OR BUILDING.
